 6.3.6 Durability The flap shall be fully opened and fully closed for the number of 60,000 cycles, without forcing built-in stops in the open position. The flap shall be gently opened and closed at each cycle without forcing dampers and/or catch devices including self-opening and self-closing mechanisms. Approximately 3 s shall be used for opening and 3 s for closing the flap. If the hinges have dampers and/or catch devices, including self-opening and self-closing mechanisms, these shall be allowed to operate correctly according to their function at each cycle. The opening and closing forces shall be applied at the middle of the flap width, 50 mm from the edge furthest away from the hinges or as specified by the manufacturer. After the test, the flap and its components shall fulfil its functions.	PASS

- 1. The dimension of the testing flap is 600 mm L x 350 mm H x 18 mm T, 2 flaps combined together;
- 2. The dimension of the cabinet is 600 mm L x 700 mm H x 370 mm D;







